Emergency Overview

Physical Description & colour: Slightly turbid colourless liquid.

Odour: Practically odourless.

Major Health Hazards: no significant risk factors have been found for this product.

Potential Health Effects

Inhalation

Short term exposure: Significant inhalation exposure is considered to be unlikely. Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation. **Long Term exposure:** No data for health effects associated with long term inhalation.

Skin Contact:

Short term exposure: This product may cause mild skin numbness due to the tau-fluvalinate (pyrethroid) but further symptoms are not available. However product is unlikely to cause any discomfort in normal use. **Long Term exposure:** No data for health effects associated with long term skin exposure.

Eye Contact:

Short term exposure: Exposure via eyes is considered to be unlikely. This product is believed to be not irritating to eyes.

Long Term exposure: No data for health effects associated with long term eye exposure.

Ingestion:

Short term exposure: Significant oral exposure is considered to be unlikely. This product is unlikely to cause any irritation problems in the short or long term.

Long Term exposure: No data for health effects associated with long term ingestion.

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak "is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

Section 4 - First Aid Measures

Section 5 - Fire Fighting Measures

Section 6 - Accidental Release Measures

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective clothing including eve/face protection. All skin areas should be covered. See above under Personal Protection regarding Australian Standards relating to personal protective equipment. Suitable materials for protective clothing include rubber, PVC. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we suggest that you use a respirator. Usually, no respirator is necessary when using this product. However, if you have any doubts consult the Australian Standard mentioned above.

Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material. Section 7 - Handling and Storage

Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Check Section 8 of this MSDS for details of personal protective measures, and make sure that those measures are followed. The measures detailed below under "Storage" should be followed during handling in order to minimise risks to persons using the product in the workplace.
